On December 7, 2013 the Northern Colorado Drug Task Force (NCDTF) served six search warrants as part of a long-term investigation into methamphetamine distribution in Larimer County. At least one warrant was served in the City of Denver.

The initial service of the warrants was facilitated with the participation of the Fort Collins Police and Larimer County Sheriff's SWAT teams and Criminal Impact Units, Fort Collins Police Neighborhood Enforcement Team, Department of Corrections-Parole Division, and the Denver Police SWAT team. In the course of the investigation, over 2.25 pounds of methamphetamine, more than \$30,000 in U.S. Currency, eleven firearms (including one illegally modified), heroin, psilocybin mushrooms, marijuana, and marijuana derivatives were seized.
